

LICENSE CONDITIONS FOR THE USE OF MARKETING MATERIALS

16. AXA Stenman Poland Sp. z o.o. shall not be liable in any way for any material or non-material damage caused to the License and/or other natural or legal persons as a result of applying this Agreement.

17. AXA Stenman Poland Sp. z o.o. is entitled to terminate the license with immediate effect in case of using the subject of the license in a manner inconsistent with these license conditions. The termination shall be effective upon delivery to the License of a written statement on termination of the license.

19. In matters not regulated in these terms and conditions of licensing, the provisions of the Polish Civil Code and the Act on Copyright and Related Rights shall apply.
